## NATIONWIDE CHECKLIST AUDIT ACROSS MULTIPLE FINANCIAL BRANCHES



## CHALLENGE

A security consulting provider required a company capable of conducting a simultaneous checklist audit across 301 branches nationwide, with strict requirements for security and confidentiality. The customer emphasised that the information gathered, such as survey responses, photographs, and signatures from branch managers and visitors, should never be stored on local devices (smartphones or tablets). They needed a solution where data was transferred directly to servers without leaving traces on the devices, reducing the risk of information loss during transmission.

## WHY RGIS?

The security consulting provider chose RGIS due to its robust operational capacity and logistical expertise. RGIS's ability to deploy large-scale resources and adapt technology to meet specific customer needs made them the perfect partner for this project.

## OUR SOLUTION

RGIS tailored a solution using the Delivery Check application, customised to meet the customer's security and data protection requirements. Key aspects of the solution included:

- **Nationwide Deployment:** RGIS deployed 301 people across the country, with each assigned to a branch to conduct the audit simultaneously. The audits were performed on the same day and at the same time, ensuring consistency in data collection.
- **Data Protection and Transmission:** The Delivery Check app was adapted to ensure that no information was stored on the auditors' devices. Instead, the data – such as survey answers, photographs, and signatures – was immediately transferred to temporary tables on the app and sent directly to RGIS's servers, minimising any risk of data loss during transmission.
- **Handling Large Data Loads:** Some branches required the collection of over 350 photographs. RGIS's solution ensured that all this data was transmitted securely and efficiently.

## RESULTS

- **Operational Excellence:** The security consulting provider was highly satisfied with RGIS's logistical capabilities and operational deployment. The personnel followed the detailed procedures for branch visits, ensuring the audit was completed as planned.
